- 10. If there were an issue to be voted on that you either did not fully understand or did not have time to fully review but you understand that the majority of Council will vote for the particular issue, what would you do?
- 11. If you were appointed to Council and Orange High School were to ask you to give a presentation on morals and ethics in government, what would you say?
- 12. Do you understand the process of consensus and that Council works to build consensus?
