REGULAR COUNCIL MEETING February 8, 2017

MINUTES

The Regular Council Meeting of the Village of Moreland Hills was called to order by Mayor Renda at 7:00pm, in the Village Council Chambers.

Finance

Mr. Shah did not have a report.

REPORTS OF COMMITTEES

Roads & Safety Committee

Mr. Richman reported that the committee met on January 31. Chief Wyant received \$3740 for CPT (Continued Professional Training). The Police Department will be requesting two replacement vehicles this year; one to replace the Chevy Tahoe that has approximately 100,000 miles on it and one to replace the Sedan that has 80,000 miles on it.

Mr. Filarski presented the summary of the road program, as he did just prior to this at the Committee of the Whole meeting. He also gave a report on the Culvert and Drainage program for this year; it is estimated at \$70,000 and there is \$27,000 available from a prior NEORSD grant from last year that can be applied to this year's program. Mr. Stanard asked if Chief Wyant has already planned for these replacement vehicles. Mr. Richman stated that it has not gone to budget approval yet and stated that these are just items that he will be bringing forth for approval. Mr. Stanard asked if it they were included in the fund put aside for replacement vehicles or if the fund only applied to Service Department vehicles. Mr. Shah stated that the replacement fund includes both Police Department vehicles and Service Department vehicles.

Facilities Committee

Ms. Sturgis reported that the committee met on January 31. The status of each Village building will continue to be evaluated as far as maintenance requirements and will brought to committee for discussion. The WEB Area study will be available for Council and the public to view on the website as well as in paper form which will be available in Village Hall. A grant in the amount of \$739,220.00 was obtained for this project to help defray the cost on the sewer/septic replacement in that area. There will be a study to evaluate the flow of Winterberry Pump Station, which will begin in May so that they can get a good read on it; the length of the study has not yet been established. The Roads and Safety Committee as well as the Facilities Committee will now be meeting on an every other month basis. The Historical society has done some research and are proposing a name for the cabin to be "The James A. Garfield Birth Site Park," which will be an upcoming resolution at a future Council meeting. The next meeting is scheduled for February 28.

Ms. Sturgis informed Council that there will be a Meeting for the residents of the WEB area on February 21st at 7:00pm at the Orange High School Cafeteria to discuss the study regarding the WEB area septic issue. Mr. Richman asked if there are potential issues with the Winterberry Pump Station or is it just a routine study. Mr. Filarski stated that there is some stormwater infiltration there, so in order to identify possible sources, he stated he is recommending the study be done.

BZA

Mr. Stanard reported that the BZA met on January 30 with one item on the agenda. Sunoco was requesting a variance of 15.5 sq. ft. for monument sign, which had been tabled at the November meeting. The sign has a brick base with half the sign indicating the price of gas and the other half with the "Sunoco" logo on it. He stated that the board did determine that it was the minimum variance that would mitigate the request because it was the smallest sign Sunoco could get to include both their logo and the cost of fuel. They were able to reduce the height of the sign from their original request, which eliminated their need for a height variance which they had originally requested. They also satisfied Mr. Filarski's request by moving the location to the best line of sight location. Sunoco's variance was granted.

Planning Commission

Mr. Stanard reported that the Planning Commission met on January 30, immediately following the

BZA meeting. Sunoco was on the agenda requesting approval of the actual sign, which was granted. There were two lot splits on the agenda. The Snavely residence on Bentleyville Road requested to split a portion of their lot, which would then be sold to and consolidated with a lot owned by the neighbor, Risman. The other lot split was for 415 Chagrin so that they could make enough room for a driveway, because of the steep grade. They had been using an easement but they wanted to memorialize the easement with a lot split, making just enough room at the entrance on Chagrin Blvd. for an appropriate drive without cutting too deeply into the steep embankment. Both lot splits were approved. The Puflea residence on 280 Miles was on the agenda with plans for a new home, however the location is 40% in Moreland Hills and 60% in Chagrin Falls, so it was just a courtesy look for us. It was already approved by the Chagrin Falls Planning Commission. There will not be a meeting in February because the schedule will be shifting to the first Monday of every month making March 6 the next meeting date.

At this time, Mr. Fritz stated to Council that each year they make a donation to both Chagrin Falls and Orange's After Prom. He stated that with a heavy heart, he would like to suggest that they make both donations in remembrance of Chagrin Falls Senior Grant Wilson. Mr. Fritz explained that on December 31, 2016, his son's best friend, Grant Wilson, had been killed. He expressed the sadness this loss brought his family as well as the devastation it brought Grant's family. Mr. Fritz shared some pictures of Grant and told stories of him dressing up and walking around as Batman and playing the guitar at the top of the falls or in Starbucks.

Mr. Fritz made a motion seconded by Ms. Sturgis to make a donation of \$500 to the Chagrin Falls High School After Prom, in remembrance of Grant Wilson.

Mr. Buczek stated that there are requirements under the EPA for our NPDES permit for stormwater management. These are services provided by soil and water conservation district and the sewer district. NEORSD will reimburse the Village the \$5,000.

Mr. Stanard stated that the Code currently reads that fences in the front and side yards are to be 50% open. In order to make rules consistent, this ordinance will add "rear yard" to that stipulation.

AN ORDINANCE AMENDING CHAPTER 1151, "U-1 DWELLING HOUSE DISTRICT REGULATIONS" OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MORELAND HILLS, OHIO TO PROHIBIT FRONT FACING, ATTACHED GARAGES AND PROVIDING AN EXCEPTION FOR ATTACHED GARAGES LOCATED ON WILTSHIRE ROAD, ELLENDALE ROAD, AND BERKELEY AVENUE.

Mr. Stanard stated that this ordinance will prohibit front-facing attached garages, unless the garage is located on Wiltshire, Ellendale, or Berkeley or in the U5 District.

AN ORDINANCE AMENDING SECTION 1173.07(f)(1), "uses prohibited in Riparian Setbacks," of the codified ordinances of the village of moreland hills to permit construction of small structures in the Riparian Setback.

Mr. Buczek stated that this ordinance deals with allowing buildings up to 200 sq. ft. to be built in the riparian setback, with the Village Engineer's approval.

Mr. Stanard stated that this ordinance refers to "Footnote C" and stated that it is complicated. It relates to preventing a huge side of a building close to a neighboring property line. While the intent of the ordinance was clear, enforcement has been quite confusing for some time and therefore needs to be clarified.

Mayor Renda stated that this is one of those ordinances where it was realized that they were providing more variances for it than actually using the ordinance itself. She stated that the intent was good, but it needs to be revised and fixed.

Mr. Buczek stated that this is a clean up of this ordinance. The maximum grade of a driveway is 10% and the verbiage needs to be added to additional sections of the Code.

Mr. Stanard stated that the Village currently has rules for generators and their allowed distance from the rear and side lots. He stated that it is important to be consistent with air conditioners, air handling units, and pool equipment to make the same requirements apply. This ordinance will require several different changes because there are a number of different sections in the Code where it will need to be added.

Mr. Richman stated this would simply amend the table that labels all the zoning districts to add the new U-5 Chagrin Northwest Residential and Planned Development Conservation District, which was approved by voters in this past election.

Mayor Renda stated that speaking of the new district Mrs. Arrietta and Ms. Dean both follow the transfer of properties in Moreland Hills, and it seems that all the properties in that area have been purchased and the titles transferred.
